

# COMMUNITY VILLAGE CAMPING FORM 2011

Return completed form to Community Village Camping Co-Coordinator by the on-site meeting in June.

## PLACES TO CAMP WITHIN THE VILLAGE

- ❖ Behind/Booth Loft – These spaces should be filled first. (No visible tents during public hours.)
- ❖ Swamp – Behind Doors of Expression and Wild Edibles
- ❖ Meadow – Beyond the Yurt and Tipi, some 4-A camping
- ❖ Council – Small camp twixt Swamp and Meadow, for Council

## PLACES TO CAMP OUTSIDE THE VILLAGE (These areas have a Village section.)

- ❖ Zenn Acres At Aero/Chickadee. Quieter camp. No parking or vehicle camping.
- ❖ Far Side -- Across Long Tom (vehicle access via Territorial Rd.) The Village camp is on the far side of Far Side. Vehicle camping and some parking allowed. No vehicle in/out privileges. Far Side vehicle sticker required. Request Far Side vehicle sticker when registering with your Booth Coordinator.

*NOTE: No matter where you camp at Fair, fill out a camp form. We need to know where you are. Thanks.*

- ❖ Each tent (or Parent/Child group) needs one (1) completed form.
- ❖ SOs share your tent. Bring an appropriate size tent – no 10'X10's for 1 or 2 people. If you want to camp as a group, arrive together or bring all tents.
- ❖ After you get your wristband, check in with your camp host to get your tent tag. In the Village, this happens at the Info Booth (Peace & Justice side) The camping coordinator will help you find a camping spot, point out the fire lanes, fire exits, and water barrels for fire suppression. Remember, we are all on the CV fire crew. No fires permitted.
- ❖ Introduce yourself to your neighbors.
- ❖ There is *No Digging* including ground leveling. There is *No Brush Cutting*. You may gently tie back brush.
- ❖ Sweep happens at closing. Check your tent. You must participate in 2 sweeps. Everyone sweeps on Saturday.
- ❖ Recycle daily. Pack it in/Pack it out.
- ❖ If you are staying overnight Sunday night to work Monday morning, all tents must be down by 10AM Monday.
